ADDITIONAL CHARGES

1. Network Blocking \$10 for each excessive call attempt within any measured 1/4 hour period.
2. Operator Service Aggregator access charge:
\$.47 Per Private Pay Telephone Per Month

800 SERVICE/CANADA ORIGINATION - \$.2700 Per Minute

Calls terminated to a U.S. location designated by the Customer may be originated in Canada using an 800 number which is then routed through the Company. Calls are billed in six second increments with a 30 second minimum. Any fraction of an increment is rounded up to the next whole increment. This capability is subject to availability of certain 800 numbers which can originate calls in Canada.

SENT PAID CALLS

The following rates are applicable to interstate and international (As specified) sent-paid calls from Ameritech designated telephones which when the call from that telephone is forwarded with a pseudo-ANI's.

Charges for domestic interstate sent-paid calls are charged the rates set forth as follows for the specified time periods. Calls are billed in one minute increments with each partial increment rounded up to next whole increment:

Charges applicable to international calls are as specified below and are billed in one minute increments with each partial increment rounded up to the next whole increment. Calls are rated according to the time periods specified:

Calls to Canada: The time periods applicable are set forth in Section 3.1.1.

All other international calls: The timer periods applicable are set forth in Section 3.6.

SECTION 5 - PROMOTIONAL OFFERINGS
