III. SPECIAL CONDITIONS

A. General

The Utility will deliver telephone traffic to and receive telephone traffic from an OSP only via switched access facilities, as described in Schedule Cal. P.U.C. No. C-1.

An OSP may process intraLATA, zero-plus (0+), non-sent-paid calls originating within the Utility's operating areas from a customer-owned pay telephone.

An OSP may not process intraLATA, zero-plus, non-sent-paid calls originating within the Utility's operating areas if the call does not originate from a customer-owned pay telephone.

An OSP may not process intraLATA, zero-minus (0-) calls originating within the Utility's operating areas.

The rates, charges, regulations, definitions, terms, and conditions contained in Schedule Cal. P.U.C. No. C-1 in relationship to intrastate FGA are also applicable to the intraLATA services provided from this schedule as authorized in D.90-06-018.

Calls routed to an OSP for billing and collection purposes must be routed over facilities specified in section II. <u>RATES</u>, preceding, of this schedule or specified as FGA in Schedule Cal. P.U.C. No. C-1.

An intraLATA call sent to an OSP for processing must be returned to thee-same central office to which the OSP connects directly to the Utility's network.
